#### **Boxing Day floods**

Villagers in Wilberfoss have said a big thank you to seven of East Riding of Yorkshire Council's grounds maintenance team who spent 16 hours battling to prevent flood water reaching their houses after the village beck burst its banks. Council staff worked tirelessly to save more than 50 homes from flooding on Boxing Day.

Many of the properties near the beck had already suffered badly from the devastating flooding of 2007, with some residents having to vacate their homes for nearly a year afterwards.

The grounds team were out and about checking flooding hotspots on Boxing Day morning when they were called to Wilberfoss – and they immediately went to the aid of residents. Between them they delivered almost 500 sandbags – weighing a total of around six tonnes – to protect houses from water inching ever closer.

They then used a council water pump, and travelled to the Goole depot to fetch a second, larger pump, to shift water beyond the road bridge on Main Street to stop the water level getting any higher. The team was at the scene until after Iam. The team from Market Weighton, Goole and Carnaby depots returned to Wilberfoss early the next morning for a 10-hour shift to check on the situation and collect the pumps.

#### Is your Emergency Plan up to date?

Several parish councils were contacted to warn them about high rainfall that fell over Christmas and New Year, and the rise in river levels. They were also asked to consider activating their Community Emergency Plans and some parishes did.

In some cases this showed contact details had become out of date, through changes in parish councillors and different contacts in the public services. Perhaps now is a good time to review your plan and update it? If you do, send an updated copy to the emergency planning team at heps@eastriding.gov.uk

Humber Emergency Planning Service's website at heps.gov.uk contains useful information to help plan ahead to minimise the impact of emergencies.

#### Opportunities for young people to help local communities

East Riding Voluntary Action Services will deliver the 2016 National Citizen Service (NCS) for 16-17 year-olds in the spring and summer. The scheme allows young people in the East Riding to give 30 hours to help local communities.

Projects in 2015 included improving access for clients to the garden area at Priory View Day Services Centre in Bridlington, painting and decorating The Pavilion in Roos and painting and decorating North Frodingham's village hall.

NCS is a nationally-recognised programme to help young people with future education, training and employment applications, including university. The young people graduate with a recognised qualification in first aid, as well as taking part in a range of activities, workshops and learning discussions.

#### Library consultation

Nearly 8,000 people have had their say on the future of libraries in the East Riding in the first phase of the public consultation, which finished at the end of December.

The results are being analysed to determine what, if any, proposals, are going to be put forward for the future of the service. If there are any, these will be consulted on later in the year.







Rural broadband

Latest figures show more than 42,000 premises across the area now have access to superfast broadband thanks to the Broadband East Riding programme. East Riding of Yorkshire Council's project working with BT has helped to upgrade more than 200 cabinets with fibre optic and laid almost 300km of fibre duct.

This year, Broadband East Riding will start helping to connect a further 4,500 premises in rural areas; working towards the national ambition to make superfast broadband accessible to 95 per cent of the country by 2017.

#### **Events on council land**

Many town and parish councils hold events on council land, helping charities with their fund-raising activities, attracting visitors and helping local businesses with extra trade and economic activity.

The council's application process for events on its land is explained in a guidance document. It is available, together with an application form, to download from the website www2.eastriding.gov.uk/leisure/events/organising-an-event-on-council-land/

At least three months' notice is needed to deal with the issues that must be considered when organising an event on council land. The guidance gives information about setting up an event, including requirements for public liability insurance, health and safety, food hygiene and other licensing, and preparing risk assessments.

The council asks commercial organisations like funfair operators to pay fees but there is generally no charge for the use of council land for not-for-profit charitable events, apart from an administration fee towards the cost of setting up the necessary licence agreements.

The costs vary depending on the nature of the event but many organisers take advantage of five-year multiple-site agreements that help reduce costs by requiring a one-off payment in the first year.

#### Fire Service consultation

Have you had your say about Humberside Fire and Rescue Services proposed cuts? The service is putting forward efficiency options to save money which mean some fire stations could lose a fire engine.

#### **Drug driving**

A new law came into place a year ago to deal with the increased number of people driving while under the influence of drugs. Since March 2015 drivers can be tested for drugs as well as drink at the road-side.

The police can now use testing kits on drivers that they suspect of driving under the influence of drugs.

The penalties for drink or drug driving are the same.

If you are convicted you will receive:

- a minimum 12-month driving ban
- a criminal record
- a fine of up to £5,000 or up to 6 months in prison, or both.

#### Shiptonthorpe people power

The village hall has recently been successful with its bid to the OneFamily Foundation for £5,000 for stage lighting. Applications to the fund are submitted and posted on its website.

#### Good recruitment practice

ERNLLCA is often asked about a best practice approach to recruitment. Technically there is nothing in employment law which requires an employer to advertise a vacancy but parish and town councils, as public bodies, must consider issues of equality of access and openness in making the decisions about recruitment.

Where a council opts to advertise a vacancy, the best and safest approach is to determine the terms and conditions of employment before any advertising is carried out. These details can then be used in the advert and will act as a positive aid to attracting the right calibre of candidate. Adverts using a phrase such as "salary according to experience" are more or less meaningless. Additionally phrases such as "for details of the role please contact the Chairman" are unlikely to enthuse good potential candidates.

There is a high turnover of Clerks in the ERNLLCA area and our research shows that the ■ "under-selling" of the role is a major contributor to this problem. Properly assessing the position prior to advertising will give the candidates, councils want to attract, a clearer picture of ■ what is involved. ERNLLCA therefore strongly recommends that councils revisit the job description and person specification for the post and make sure they reflect what is needed. Additionally the main terms and conditions of employment should be checked (i.e. salary level, ■ hours and place of work) and agreed to make sure they reflect what is actually needed, as opposed to what has always been applied. ERNLLCA can offer assistance with salary assessiment. Anyone applying for a vacancy initially wants to know some bits of vital information how many hours of work are involved and what is the rate of pay. It is also important to remember that parish and town councils, as public bodies, should be open and transparent in all their dealings so this is basic information that should be offered within the advert.

Councils must select staff on merit and be able to prove that they have done so. The best way to achieve this is by using an Application Form, a standard document which all applicants can complete giving the council an easier means of measuring one candidate against another. A sample form is available from ERNLLCA, nobody has to reinvent the wheel or use examples from other industries or sectors, which may be wholly inappropriate.

■ ERNLLCA can carry your advert on the website and ensure existing Clerks, who may be look- ■ ing to take on another council, are alerted to the vacancy.

#### **Transparency Code for small councils**

There is still time for councils with an annual spend of less than £25,000 to apply for funding to meet the costs of creating a website to house the information required by the Transparency Code. To date £25,443 has been allocated to councils in this area with a further tranche to be paid early in February.

This initiative has come about because councils spending less than £25,000 per year are to be exempted from the need for an external audit after April 2017. The Government wishes to ensure that openness and transparency continue to lie at the heart of parish council life by ensuring that the public have electronic access to information about the finances and general business of their council. All eligible councils have been sent a copy of the Transparency Code by ERNLLCA in which is listed all of the documents which must be published on the council's website and in what timescale.

Funding is available to help councils make this transition and the grant application form is available from ERNLLCA.

Completed grant forms should be returned to ERNLLCA which will "triage" applications before forwarding them to the Assessment Panel for a decision.

#### **Advanced Chairmanship training**

We are pleased to announce that this popular and well-received course is being re-offered to councils. Details of dates and venues have been sent to member councils and booking forms can also be down-loaded from the Training & Conferences page of the ERNLLCA wesbite. The course, which is in three parts, will cover:

<u>Conduct</u>: Statutory responsibilities; Handling conflict; Dealing with the public and media; and Public relations role. <u>Challenging meetings</u>: Chairing skills; Assessing your members' knowledge and skills; Influencing, facilitation and control; and Question and listening skills. <u>Visionary Leadership</u>: Concept of leadership; Building partnerships; and Community cohesion.

#### **Community Buildings Grants - Locality**

Any Town or Parish Council, Neighbourhood Forum or qualifying community group can apply for Pre-Feasibility grants (£1000 to £10,000) and Project Support grants (£5000 to £40,000) to help move a community building or community housing project to the point at which a Community Right to Build Order, or (in the case of community led housing projects only) a traditional planning permission application, can be submitted. These are revenue grants which mean they do not cover the capital costs of land acquisition or actually constructing a building.

#### 1. Priority

**Issue:** Youths causing annoyance around the areas of the Church and playing fields in Gilberdyke.

Throughout February, officers will continue to patrol the above areas on Clementhorpe Road to deter any potential antisocial behaviour. Anyone caught engaging in anti-social behaviour will be dealt with under the FAIRWAY process jointly with East Riding of Yorkshire Council. It is unlikely that any discretion will be shown.

#### 2. Meetings

PCSO Simon Palmer will be holding a "Police Drop In" surgery at the Travelling Library, Gilberdyke Memorial Hall car park, Clementhorpe Road, Gilberdyke on the 24<sup>th</sup> February (14:00-15:00)

#### 3. Crimes in your area

- Entry was gained into a secure building site in Gilberdyke and 3 pallets of insulation and a half pallet of cement were stolen.
- Up to 14 Birds were taken from an Avery in a rear garden in the Holme on Spalding Moor area.
- 6 Ducks were stolen from an enclosure in Laxton.
- 2 Giant road bicycles were stolen from a secure wooden shed in North Cave.
- Entry was gained into a secure log cabin in Bubwith and various tools were stolen.
- Entry was gained into a secure property in Gilberdyke and keys to 2 vehicles (a transporter van and a Mercedes C60) were taken which resulted in the vehicles being stolen the van was later recovered near Rawcliffe.

#### 4. News and Appeals

#### YOUR HOME - KEEP IT SAFE, KEEP IT LOCKED

Burglary is by and large an opportunistic crime, with burglars looking for a home that gives them the easiest way of committing their crime undetected and with the fewest obstacles to negotiate. In many cases burglars do not need to use ANY force to gain entry which can be via an insecure window or door. So how can you keep your home and property safe?

Make your home looked lived-in by leaving a radio on or a light on a timer switch to make the house sound and look occupied

If you are going away remember to cancel the milk or newspapers. Don't make it obvious to burglars you are away. Don't close your curtains - in daytime this shows the house is empty. Use timer switches on lights instead

and if possible ask a trusted neighbour to close your curtains in the evening, to collect your post and also ask if they would park their car on your drive whilst you are away.

Never leave your spare keys in a hiding place such as under a doormat, in a flowerpot or inside a letterbox.

Make sure you use a burglar alarm (if you have one) every time you leave the house.

Secure your garden with a fence and a lockable gate.

Don't leave tools or ladders in the garden to assist burglars and secure your wheelie bins away from your house, fences and walls.

Think about installing a movement activated floodlight as it can unnerve burglars.


Keep doors and windows locked even when at home.

Don't leave valuables on view or on window sills and keep your car keys hidden out of sight.

If your property is stolen make sure you can describe it to the Police by keeping a record and photographs of makes, models and unique serial numbers etc.

You can also register all your details onto <u>WWW.immobilise.com</u>. This is a web based property records system, endorsed and searchable by all UK Police Forces and second hand dealers.

# No tools? No van? No liveli



- Remove all tools & equipment from the van whenever possible, particularly overnight.
- Use busy, well-lit and secure parking areas.
- Consider alarming the vehicle or fitting an internal security cage or metal chest inside and ensure it is securely bolted down with a good quality padlock.
- Security mark all your tools and equipment to make items uniquely identifiable and less attractive to a thief.
- Keep a list of tools, together with serial numbers and any identifying marks on immobilise, a free national property register www.immobilise.com. This will help to trace them back to you if they are recovered.
- Keep your van keys safe while you are working. Never leave them in your vehicle.
